CHAIRMAN'S REPORT:

TREASURER' REPORT:

We currently have £5013.54 in the bank. Plus £299.15 coinage. Wickham Bishops Hall costs were £1996 this year. Other recurring expenses each year are for access to the Bridgeweb system and Xmas Party food provision. Excess of income over expenditure for the period 2nd October 24 to 1st October 25 was £937.15. There were no renewals of equipment such as cards, bidding boxes, duplicate boards and currently the equipment needed to connect to the bridgeweb system such as a dealing machine and old phones for wireless scoring are provided by Bill. We have enough reserves to deal with any equipment renewal as well as recurring costs so we will not need to make any changes to our Membership of £10 or our table money of £2 for members and £4 for guests. We currently have 37 paid up members. Membership is now payable for the coming year. Acceptance of Accounts 2024-2025 were proposed by David Croom, seconded by Phil Tucker. PROPOSALS TO THE MEETING:
