	• The ESC (Emergency Sub-Committee, CS, DE and GC) has been meeting	
	regularly and providing updates to the Committee. The Committee is very	
	grateful for the considerable amount of work being undertaken by the ESC in	
	very difficult circumstances.	
	The current focus of the ESC is in two areas – staff deployment and facilitating	
	online bridge.	
	WBC is keen to encourage our members to participate in bridge online. WBC	
	uses BridgeBaseOnline (BBO) to play daily duplicate sessions. Instructions	
	for joining BBO and accessing the sessions are given on the WBC website.	
	The plan is that there will be special sessions on a Sunday morning, gentle or	
	social sessions on a Tuesday and Thursday morning and normal duplicate	
	sessions at other times. More details of the timetable and description of these	
	sessions is also on the WBC website. The sessions are already proving	
	popular and numbers are increasing. GC is spending time each day facilitating	
	these games for members, helping out with problems on accessing the games	
	and then supporting members as they play.	
	The BBO site has experienced traffic volume problems several times in the	
	evenings as it struggles to cope with the volume of traffic, especially when the	
	USA games come online. If evening sessions continue to be problematic then	
	WBC may play daytime sessions only.	
	There is a cost to the Club of running these sessions including a fee per player	
	having to be paid to a third party who actually facilitates the sessions. At the	
	moment the Club is not charging players (although other Clubs are charging	Juliet/Grahan
	their players). The majority of the Committee agreed that donations should be	Juliel/Granan
	sought from WBC members to help offset the cost to the Club. GB and JB will	
	write an email to be sent out to all members.	
	In using BBO, WBC members are encouraged to give their 'real' name in their	
	profile online (under the 'account' heading). Members are also asked to give	
	brief details of their conventions in their profiles. These suggestions will help	
	the sessions run smoothly and bring some human dimension to the	
	experience.
